Halal Certification Requirement



Under the Muis Halal Certification Conditions, it is **mandatory requirement** for the following personnel to be assessed as competent:

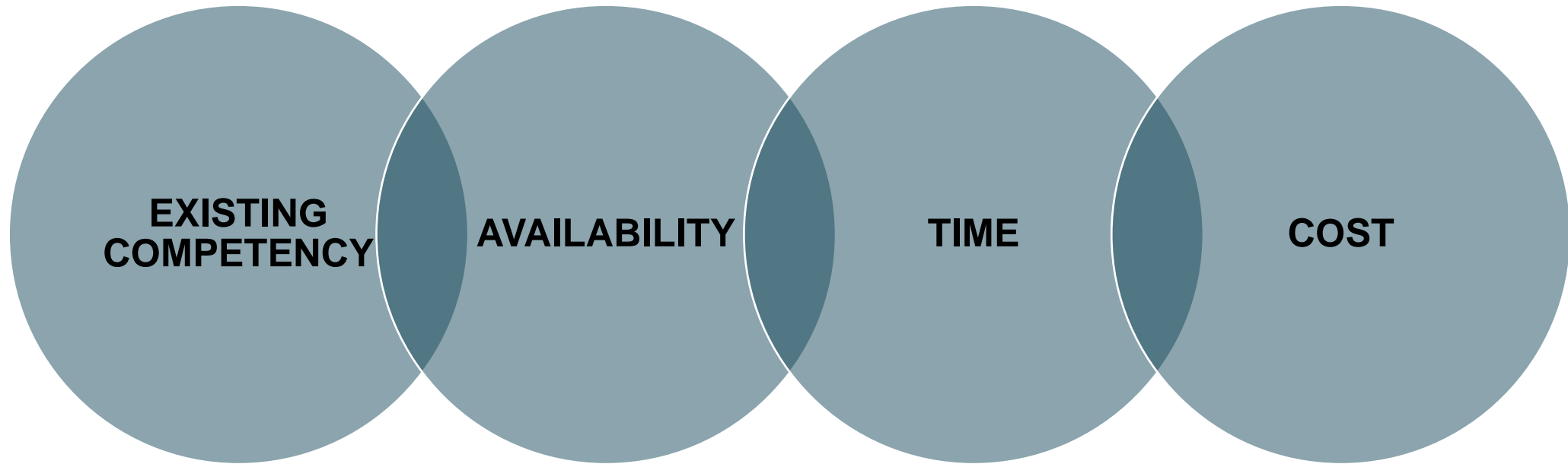
- ◆ **Eating Establishment – Category 1**

- i. Owner Representative
- ii. Muslim Personnel

- ◆ **For all other schemes**

- i. Halal Team Leader
- ii. Halal Assurance Officer

New initiatives effective April 2023



1 HALAL COMPETENCY ASSESSMENT (HCA)

HCA is an assessment to **recognise individuals' Halal competency** as part of the **requirement for Muis Halal Certification**. Upon passing the HCA, the individual will be awarded with HCA Certificate.

Individuals may choose to attend and pass either (a) Training & Assessment or (b) Assessment-Only Pathway.

Halal Competency Assessment (HCA)

WHAT IS HALAL COMPETENCY ASSESSMENT (HCA)?

HCA is an assessment to recognise individuals' Halal competency as part of the requirement for Muis Halal Certification.

The HCA will **replace the assessment portion** of the previous **Halal Foundation Programme (HFP)** and current **Halal Certification Training (Foundational Level)**.

Upon passing the HCA, the individual will be awarded with a HCA certificate. The HCA certificate will only be valid for 5 years.



WHAT IS ASSESSMENT-ONLY PATHWAY (AOP)?

A new Assessment-Only Pathway (AOP) will also be made available for individuals who are already well-informed on the Halal basics and principles.

The AOP will allow individuals to be recognised as Halal-competent **without undergoing the full training course**.

WHO NEEDS TO SIT FOR THE HCA?

If you wish to take up one of the following roles for your establishment, you will be required to sit and pass the HCA.

FOR EATING ESTABLISHMENT SCHEME - CATEGORY 1:	FOR ALL OTHER SCHEMES:
(i) Owner representative (ii) Muslim personnel	(i) Halal Team Leader (ii) Halal Assurance Officer

HCA Registration and Payment



- ❖ Registration for assessment slot opens on **27 March 2023**
- ❖ Assessment will be on **available for April 2023 onwards**

There are 2 ways to register for HCA:

1. **Through WHL's training course (HCT-FL)**

- ▷ HCA fee will included as part of course bundle: **\$350*** (before 8% GST)

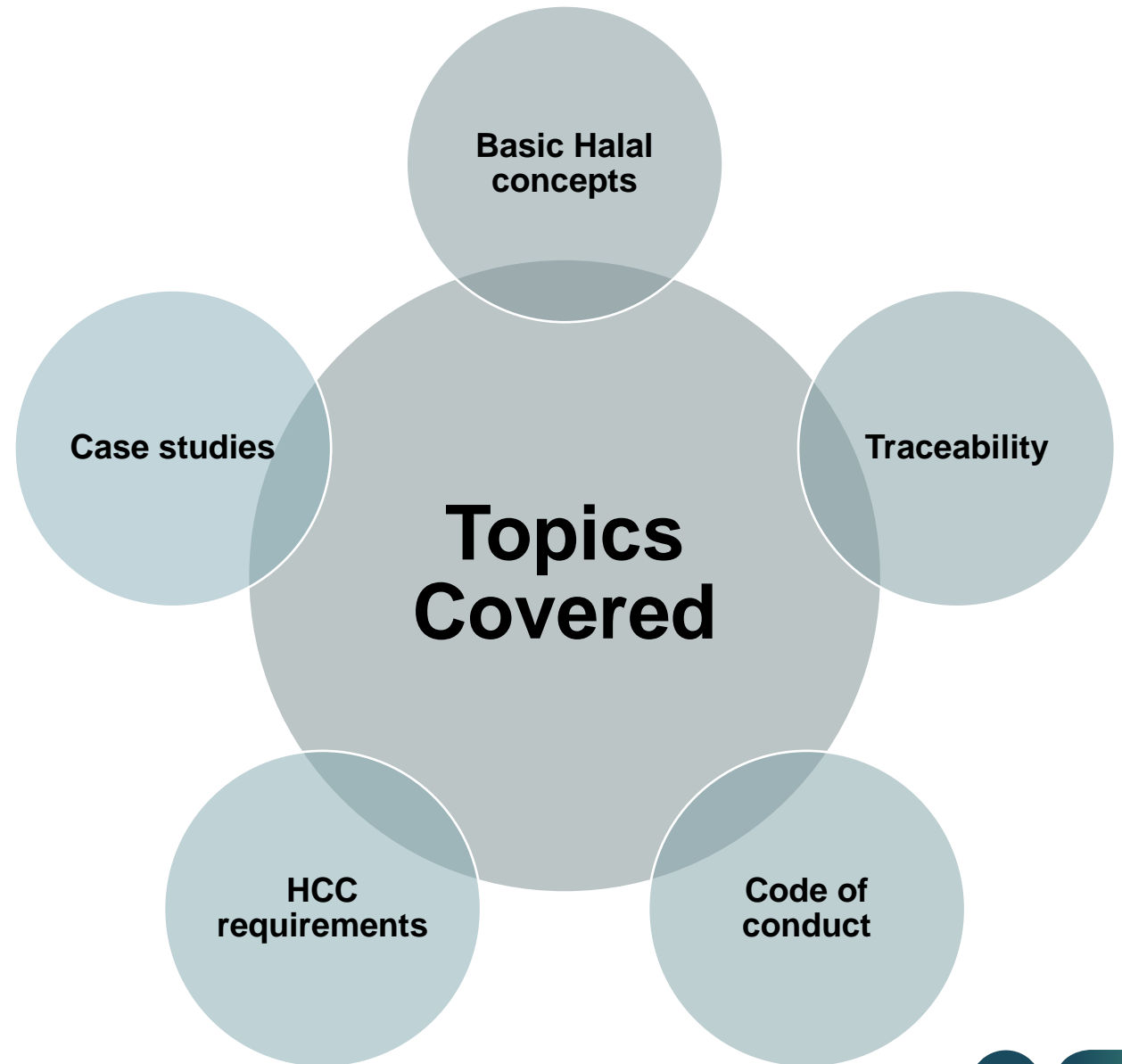
Note: Fee payable for HCT-FL is for online training with **one sitting of HCA. Fee for classroom or blended training differs.*

2. **Direct registration with Studyworks**

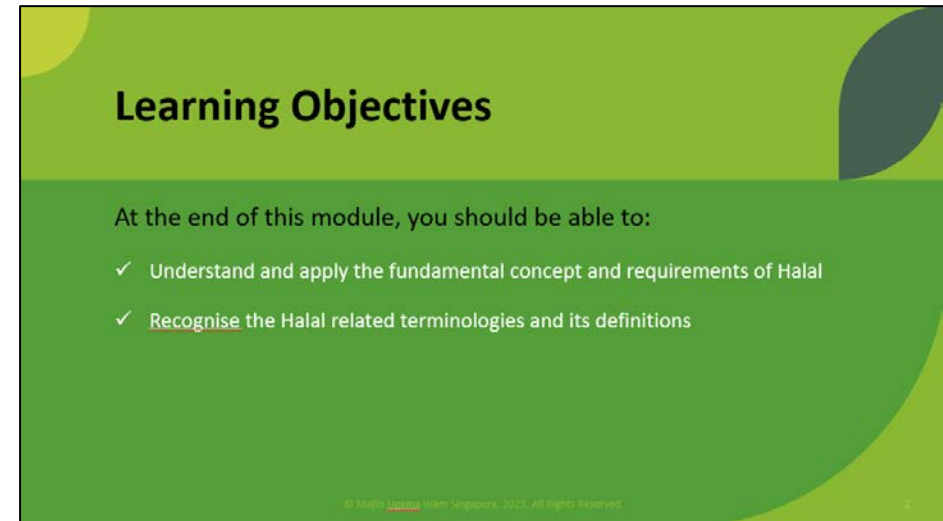
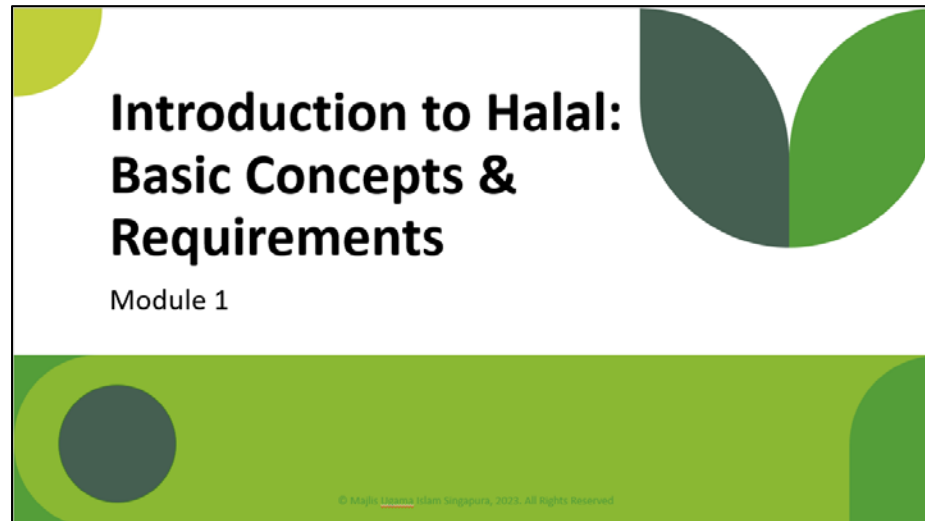
- ▷ Payable via credit card: **\$125** (before 8% GST)

Benefits of HCA

S/N	Pain points from feedback received	Addressing pain points through HCA
1	COMPETENCY	Some personnel are well equipped in Halal knowledge and principles can opt for the Assessment-Only Pathway (AOP)
2	AVAILABILITY	Assessment dates will be made available all year round. Reading materials and references will be made accessible for self-learning
3	TIME FACTOR	Assessment only last for 90 minutes with almost immediate results
4	COST FACTOR	Fees will be minimal (less than training courses)

1 HALAL COMPETENCY ASSESSMENT (HCA)

HCA is an assessment to **recognise individuals' Halal competency** as part of the **requirement for Muis Halal Certification**. Upon passing the HCA, the individual will be awarded with HCA Certificate.

Individuals may choose to attend and pass either (a) Training & Assessment or (b) Assessment-Only Pathway.

2 MANDATORY REFRESHER REQUIREMENT

HCA Certificate is only **valid for 5 years**. Subsequently, personnel will be required to attend and pass the HCA to be deemed competent.

Mandatory Refresher Requirement

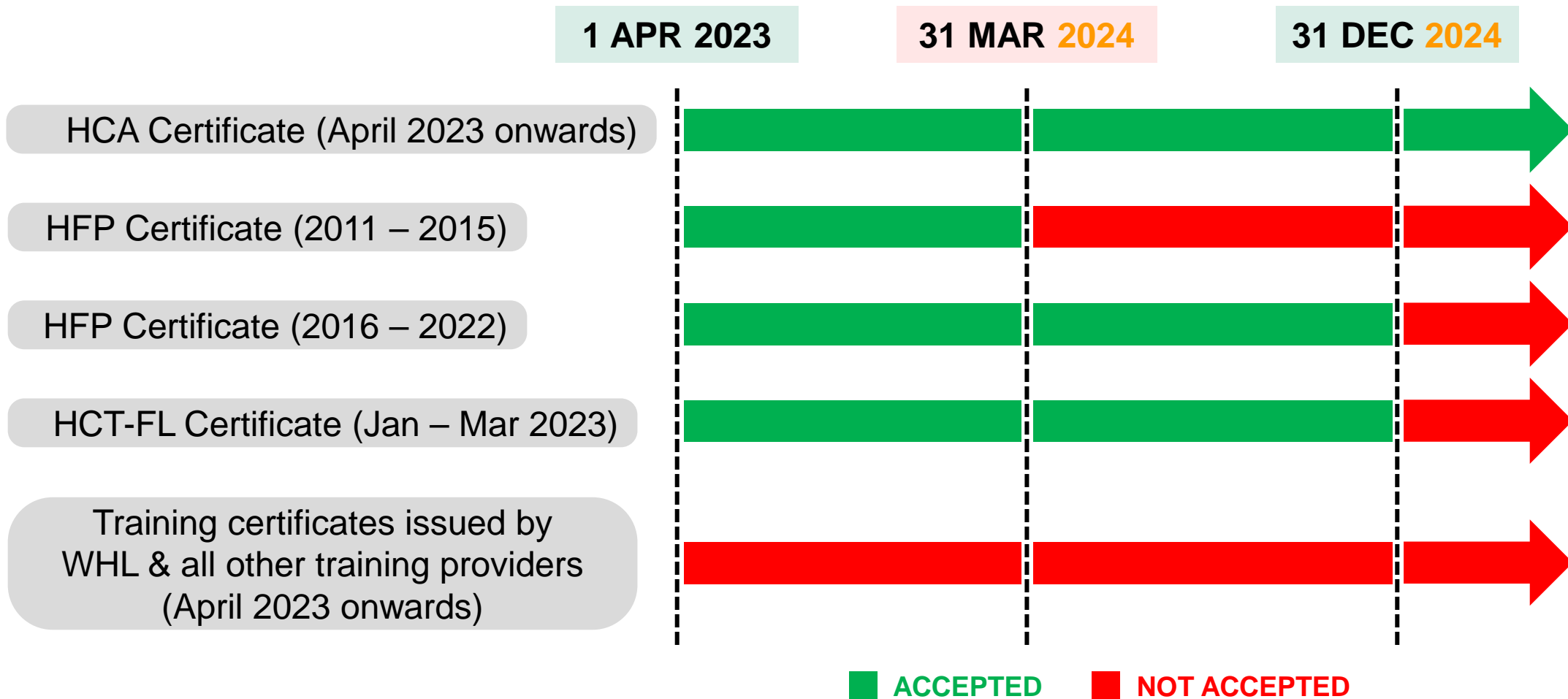
REFRESHER REQUIREMENT : SUCCESSFULLY COMPLETE HCA – every 5 years

- ▶ 2-stage transition for **existing Halal training certificate holders**
- ▶ Once transition period ends, the previous HFP / HCT-FL certificates will no longer be valid

Transition	Year of HFP / HCT-FL awarded	Transition end date
Stage 1	2011 – 2015	31 March 2024
Stage 2	2016 – 31 March 2023	31 December 2024

- ▶ HCA certificate is **only valid for 5 years**. Competent personnel will need to pass subsequent HCA 5 years from the last HCA passed date

3	End of Stage 1 Transition Period for use of Training Certificates to fulfil HCC requirements	31 Mar 2024
4	End of Stage 2 Transition Period for use of Training Certificates to fulfil HCC requirements	31 Dec 2024
