IMPORTANT NOTES ON THE MEDICAL REGISTRATION ACT 1997

SECOND SCHEDULE – LIST OF REGISTRABLE BASIC MEDICAL QUALIFICATIONS*

- 1. The Singapore Medical Council ("SMC") may consider granting medical registration to International Medical Graduates ("IMGs") whose basic medical qualifications are listed in the Second Schedule of the Medical Registration Act 1997 (the "Schedule").
- Only the medical programme from the listed medical schools at the time of addition to the Schedule is recognised. Any subsequent significant changes to the medical curriculum of the listed medical school may not be recognised, e.g. GCE Advanced level or Baccalaureate level entry to a Graduate entry programme.
- 3. Only the main campus that was in existence at the time of addition to the Schedule will be recognised. Any campus that is off-site from the recognised main campus, whether in the same country or a different country and whether the same degree is granted or not, will not be recognised by the SMC.
- 4. In general, doctors who hold qualifications from programmes involving twinning arrangements and who are applying for Provisional or Conditional registration must have completed their entire clinical training, taken their final examinations, and received their final qualification at the respective main campuses of the medical schools listed in the Second Schedule. However, graduates from medical schools in Malaysia, the United States of America (USA) and Canada which are listed in the Second Schedule are required to have completed both pre-clinical and clinical training entirely at the respective main campuses of the medical schools listed in the Second Schedule.
- 5. Graduates from recognised medical schools listed in the Schedule must pass the relevant national licensing examinations in the listed country, e.g. in the USA, medical graduates must pass the USMLE and in Canada, they must pass the MCCQE to be registered to practise in Singapore. For any country that imposes such national licensing conditions on its own medical graduates, the corresponding conditions will also be required for registration to practise in Singapore.
- 6. For <u>Utrecht University</u>, <u>Faculty of Medicine UMC Utrecht</u>, <u>Netherlands</u>, the SMC only recognises the "Arts" qualification of the 6-year undergraduate medical programme. The Selective Utrecht Medical Master (SUMMA) Programme will not be recognised.
- 7. As for the <u>medical schools in the People's Republic of China</u> listed in the Schedule, the SMC only recognises the direct 7-year Master of Medicine, and 8-year Doctor of Medicine awarded by the Chinese medical schools for medical registration. The two qualifications are primary (basic) medical qualifications, and they differ from the postgraduate training programmes or qualifications that are awarded in conjunction to or after the (common) Bachelor of Medicine.
- 8. Every application for medical registration will be considered based on its own merits.
- The SMC would like to highlight that IMGs who do not hold qualifications which are recognised by the SMC will not be eligible for medical registration to practise in Singapore. This applies to all applicants.
- 10. The SMC strongly advises all interested applicants to ensure that they fulfil all necessary criteria, including but not limited to, holding a qualification which is listed in the Second Schedule of the Medical Registration Act 1997 or a registrable postgraduate medical qualification recognised by the SMC.
