Scope of the EAR

- Export Administration Regulations (EAR) generally cover
 - Most items (commodities, software, technology) in the US economy exported, reexported, or transferred in a 3rd country
 - Certain items produced outside the United States
 - More than *de minimis* (+ 25% or 10%) U.S. controlled content
 - Foreign direct products countries/end users
 - Limited activities of US persons involving items <u>not</u> subject to the EAR
- Subject to the EAR
 - Commerce Control List
 - Multilateral export control regimes
 - Unilateral controls
 - EAR99













- Russia's war of aggression against Ukraine
 - Belarus' support of the invasion
- Objective
 - Impair Russia's ability to develop, produce and field military systems in Ukraine













Scope

- Items controlled by the four multilateral export control regimes
- Unilaterally controlled items
- Harmonized Schedule categories (EAR99)
- De minimis
- Foreign direct product rule
- Iran drones
- Entity List
- Humanitarian and safety exceptions













- Global Export Control Coalition
 - 39 countries with aligned trade restrictions
 - Supplement No. 3 to Part 746 of the EAR
 - Exempt from U.S. expanded de minimis and foreign direct product rule
- Licensing policy
 - General policy of denial
 - Limited case-by-case review













Russia/Belarus Trade Restrictions EAR Part 734

- Part 734.4 *De minimis*
 - Foreign made items with more than 25% U.S. controlled content to Russia/Belarus require a license
 - Example foreign produced civil aircraft with U.S. engines likely above *de minimis* and would require U.S. export license prior to flying to Russia or Belarus from a country without comparable trade restrictions
- Part 734.9 Foreign Direct Product
 - Russia/Belarus/Occupied Crimea 734.9(f)
 - CCL items plus HS categories in Supplements 6 and 7 to Part 746
 - Russia/Belarus military end users (includes parties in third countries)
 - Identified with footnote 3 designation
 - All items subject to the EAR













Russia/Belarus Trade Restrictions EAR Part 744

- Entity List
 - Supplement 4 to Part 744
 - Footnotes 3 or 4











Russia/Belarus Trade Restrictions EAR Part 746

- § 746.5 Russian/Belarus Industry Sector Sanctions
- § 746.6 Crimea Region of Ukraine and Covered Regions of Ukraine (so-called Donetsk People's Republic (DNR) and Luhansk People's Republic (LNR))
 - 'Donetsk People's Republic (DNR) region' or 'Luhansk People's Republic (LNR) region' include land territory in those regions as well as any maritime area over which sovereignty, sovereign rights, or jurisdiction is claimed based on purported sovereignty over that land territory or area.
- § 746.8 Sanctions Against Russia and Belarus
- § 746.10 'Luxury goods' sanctions against Russia and Belarus and Russian and Belarusian oligarchs and malign actors











- Impact
 - 60% postwar decrease in key microelectronic exports to Russia
- Priority
 - Further decrease key microelectronics exports to Russia
 - 38 HS categories
 - Russia Export Controls List of Common High-Priority Items BIS website
- Need Industry Assistance
 - Prevent supply of microelectronics into Russian weapons killing Ukrainian civilians and destroying civil infrastructure and grain













October 7, 2022 Rule

Objective

- Restrict items needed for leading edge AI model training and supercomputing
- Restrict items needed for leading edge logic and memory (NAND and DRAM) integrated circuits

744.6	"U.S. Person" control for items NOT subject to the EAR
744.23 & 772.1	"Supercomputer" & Semiconductor end-use control, including new definition of "supercomputer"
734.9	New and expanded foreign direct product rules
744 supp 4	28 existing Chinese entities on the Entity List – new footnote 4 designation
736 supp 1 Gen Ord #4	6-month Temporary General License to preserve industry supply chains
740.2(a)(9)	New License Exception restriction
 January 17, 2023 (public display/effective), Interim final rule; to add Macau. (published January 18, 2023 (88 FR 2821)

Commerce Control List Controls

• Export Control Classification Numbers (ECCNs)

- Integrated circuits ECCN 3A090
- Semiconductor manufacturing equipment ECCN 3B090
- Computers containing ECCN 3A090 integrated circuits ECCN 4A090
- Associated software and technology ECCNs













End Use Controls

Supercomputers

- Product scope
 - ICs specified in ECCNs 3A001, 3A991, 4A994, 5A002, 5A004, 5A992
 - Computers, electronic assembly or component in ECCNs 4A003,4A004,4A994, 5A002, 5A004, 5A992
- End-use scope
 - For or in a "supercomputer" in or for the PRC
 - Supercomputer compute capacity in a specified physical footprint

Semiconductor manufacturing equipment

- Product scope
 - Any item subject to the EAR to advanced logic/NAND/DRAM development/production
 - Category 3 Product Groups B-E to ECCNs 3B001/2,3B090, 3B611, 3B991/2
- End-Use scope
 - Advanced logic (non-planar 16/14 nm, 128 layer + NAND, 18 nm half-pitch -, don't know)
 - Development/production of ECCNs 3B001/2,3B090, 3B611, 3B991/2













Foreign Direct Product (FDP) Controls

- 734.9(e)(2) Footnote 4 Entities
 - Expansion of Entity List FDP rule
 - Much like Huawei (footnote 1) slightly different ECCNs in product scope (includes Category 5 Part 2, instead of Category 5 Part 1 ECCNs); enduser scope is the same
- 734.9(h) New Advanced Computing & Semiconductor Manufacturing FDP rule: must meet product and destination/end-use scope
- 734.9(i) New "Supercomputer" FDP rule: must meet product and end-use scope











US Persons Control

- EAR §744.6
 - Activities which could support for WMD-related end uses
 - Items not subject to the EAR
 - Shipping, transmitting, transferring (in-country); facilitating shipment, transmission, or transfer (in-country)
 - Servicing

For the development/production of advanced logic, NAND, or DRAM in the PRC Or

Items meeting ECCNs3B090, 3D001 (for 3B090) or 3E001 (for 3B090) Knowledge or don't know
